Our new Local Plan

We are preparing a new Local Plan for 2023-2040, which will eventually replace the West Lancashire Local Plan 2012-2027 (adopted 2013). The new Plan will set out the Council's planning framework for future development in the Borough, including policies and proposals to guide the type and location of new development. We expect it will take up to 4 years to prepare the new Plan.

We need a new Local Plan to make sure our policies remain up to date so that we can appropriately manage and guide where development takes place, and deliver the correct supporting infrastructure.





The first stage in the Local Plan is the 'Scope, Issues and Options'.

The SCOPE is what the Local Plan will cover.

The ISSUES we have identified are varied and relate to:

Climate change / Nature recovery / Improving health / Housing / Employment / Retail / Leisure and recreation / Design / Place-shaping / Heritage / Community facilities / The rural economy / Education / Landscape / Flood risk / Air quality / Open spaces / Transport / Parking / Renewable energy / Energy and water efficiencies

We have then considered the planning policy OPTIONS that could help deal with these issues.

We want to know your views on the 'scope' and the 'issues and options'. Do you agree or disagree? Have we missed anything? Is there anything you think we should exclude?

We also want your views on other elements of the new Plan - its vision, its objectives, and the indicators for measuring its eventual success. There is also a range of supporting documents, including the Sustainability Appraisal and Habitats Regulations Assessment, and various evidence documents, which you can comment on.





Identifying Housing and Employment Sites

At this early stage of the Plan's preparation, we are still collecting evidence on our housing and employment needs. Until we have that information, we are not in a position to decide on how much new housing and employment land we should plan for. Neither are we in a position to choose which sites to allocate for future development. These matters will be examined in later stages of the Plan's preparation.
